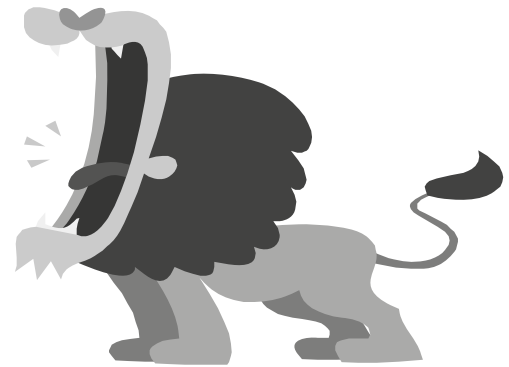

## Mini Grant Applications

The WCPG is currently accepting mini-grant applications for community based public awareness projects for the 2008-2009 grant year. Grants are generally between \$2,000 and \$5,000. To be considered, projects must meet the following specifications:

- Be tax-exempt pursuant to the Internal Revenue code 501(c) and have an IRS determination letter.
- Serve the people of Wisconsin.
- Operate, choose a governing board, and provide services without discrimination on the basis of race, religion, sex, age, sexual preference or national origin.
- Applying organizations must maintain neutrality on the issue of legalized gambling.

The mini-grant will serve as an enhancement to the statewide public awareness campaign being provided by the WCPG. These grants are for groups, organizations or agencies that are interested in promoting public awareness for compulsive gambling in their community. Public awareness can be broadly defined, but the proposal needs to be directed to Wisconsin residents and support the WCPG mission of educating the public about problem gambling and the resources available to address these issues.

## A Look at the Military and Overseas Gambling

There has been a phenomenal growth in the availability and accessibility of legal gambling, including gaming machines in formerly non-gambling venues, one of the most recent being the internet. Like the civilian population, military personnel and their families are finding more gambling available to them wherever they live. Gambling is forbidden on domestic bases but not on overseas bases. Slot machines used to be allowed on stateside bases, but after a public scandal involving the suicide of two airmen with gambling problems, the slots were removed stateside. Personnel living on overseas bases however have any number of mini-casinos to go into, regulated and non-regulated. There is no way of regulating the internet gambling that happens both in the states and overseas.

Gambling has always been popular in the military as a means to combat stress boredom and loneliness that soldiers face. Poker games have always been popular and flourish on bases although the regulations are vague on such "social games" similar to the civilian world. The armed services play a unique role as operator, regulator, and beneficiary of gambling on overseas military bases. Slots and video gambling at overseas bases brought in about \$185 million for Morale, Welfare and Recreation programs last year (2007). The Military argue that if they did not get the money from the revenue from gambling the Service members would have to pay for these services from their pockets.

Service members tend to have a higher risk of developing into problem gamblers than does the general population. They're mostly male, younger, and made up of racial and ethnic minorities-populations that have been shown to have a higher incidence of problem gambling. The Department of Defense Health Behavior Studies in 1998, 2000, and 2002 all found between 5 percent and 9 percent of military personnel had experienced a gambling-related problem in their lifetime, and about 2 percent (about 30,000 of the total force at the time) fit the classification for pathological gambling problems.

The Military has a high level of risk factors coupled with an almost nonexistent level of services to counter those risks. Plus, members of the military are often reluctant to seek help because they don't want to jeopardize their careers. For the individuals that do seek treatment, there is no coordinated, formal responsible-gaming effort, and military's sole treatment program for active-duty gamblers was recently closed, leaving service members few options for getting help. In the past two years, two Navy inpatient programs dealing with gambling addiction- one in California, one on Okinawa-were closed. The program had been successfully rehabilitating problem gamblers in the military for over a decade.

The Military recently put two regulations into effect; 1-Gambling is prohibited between people of different rank. The military does not want a private to owe money to a general or vice versa. 2- Effective March 1, 2007 Internet Gambling transactions initiated with Armed Forces Bank Visa Check Card or Business Debit Card will be declined. These transactions will no longer be allowed in accordance with the Unlawful Internet Gambling Act of 2006 which was signed into law by President Bush on October 13,
