• Utilizing the Creative Arts in Treatment

Sara Devine, MT-BC, NMT, LCSW, ICGC-II, FAMI, WMTR, Seed Inc., Appleton, WI

Do you ever feel stuck in sessions with your clients—like they're just not responding to verbal prompting? Discover how integrating creative arts into treatment can activate different areas of the brain and access memories in ways that traditional talk therapy cannot. This hands-on workshop will introduce you to a variety of creative arts approaches that can be used within the scope of your licensure. You'll learn practical techniques to better engage clients and foster intrinsic motivation for recovery—making sessions more dynamic, responsive, and effective.

• Clinical Supervision: The Role School Does Not Prep You For But Reality Does

This workshop is a blend of specific topics presented by RAP-WI. The six hour session is designed to create reflective supervision and the continual exploration of transference and parallel process. It will focus on navigating our work systems, balancing employee needs, and addressing our own personal self-care. Other areas include creating healthy workplace environments, addressing burnout, generation gaps, and other topics specific to the role of a supervisor/leadership position. This is a workshop designed to be interactive, to discuss how to address situations that often leave us feeling uncomfortable and unhappy and oftentimes are a first time experience.

• Ethics & Boundaries in Trauma Informed Care

The great majority of clients seeking behavioral health services have histories of trauma. Thursday and Friday Workshops Continued

The format used, in addition to discussion, will allow workshop participants to have the opportunity to work with actual situations where individuals have consequences that occurred as a result of problem gambling. The workshop will begin with a general discussion on the financial problems and consequences caused by gambling. The session will continue with a more in-depth approach, highlighting techniques and strategies used to deal with these problems and issues. The final portion of the workshop will incorporate what was previously discussed into practical application and role-playing activities. Session members will take on the roles of the therapists who will try to help their clients with these issues and concerns.

- **Just Let Her Breathe, Taking Care of You**

Pat Jirovetz, ATRL, LPC, ICGC-II, Creative Calm Counseling, LLC, Oshkosh, WI

Taking care of yourself is important for good mental, physical and emotional health. In this workshop there will be a hands-on experiential exercise using poetry and mandalas. Learn how taking time for yourself will help increase your mood and overall health. No art ability needed.

- **When and How Does a Problem Gambler Decide to Change Their Behavior?**

Peter Moran, MA, LPC, Qualified DOT SAP, PJM Services, Green Bay, WI

The goal of this workshop is to help participants understand the dynamics of a problem gambler changing their behavior. Through lecture and audience participation, gambler behavior change will be addressed. This workshop is appropriate for anyone interested in behavior change, gamblers, significant others of gamblers, counselors, etc.

- **When Walking Away is a Step Forward: Understanding Gambling Self-Exclusion**

Andrew J. Schreier, ICS, CSAC, LPC, BACC, ICGC-II, Community Medical Services & New Life Resources, Inc., Menomonee Falls, WI

This presentation explores gambling self-exclusion programs as a harm reduction strategy designed to empower individuals to take back control over their gambling behaviors. Self-exclusion provides a formal, structured way for people to voluntarily ban themselves from gambling venues or online platforms, creating space for recovery, reflection and healthier choices.

By looking at its history and evolution, we can understand how self-exclusion has shifted from being a paper-based administrative measure to a widely recognized and digitalized tool used across multiple states and countries. We will also examine how research has assessed the effectiveness of self-exclusion, including successes, challenges and risks. Importantly, we'll discuss how self-exclusion differs from traditional substance use and mental health interventions and why it requires unique approaches for treatment providers. Practical tips, case examples and interactive activities will give participants the tools needed to comfortably introduce, explain and support clients through self-exclusion as part of a comprehensive care plan.

- **Continuing Risk of the Gaming-Gambling Convergence**

James Schreier, Ph.D., SPHR, Independent Consultant, Beyond the Far Cliffs, West Allis, WI

This interactive workshop equips problem gambling professionals with the insights and tools to address the rising convergence of online gaming and gambling, especially among youth. Participants will explore the psychological and behavioral traits of gamers, assess risk trends using strategic foresight techniques like the Implications Wheel, and reframe the issue through the lens of paradigm shifts. Through hands-on exercises and collaborative analysis, attendees will learn to identify emerging risks, apply prevention strategies, and tailor interventions that reflect the evolving digital landscape. The workshop concludes with a creative application of gamer strengths to enhance prevention and education efforts.

- **Tailoring Motivational Interviewing to Address Youth Problem Gambling**

Ken C. Winters, Ph.D., Senior Scientist, Oregon Research Institute (MN location), Falcon Heights, MN

Motivational interviewing (MI) is an evidence-based clinical tool in the addiction treatment field. Tailoring MI for certain clients and target problems is showing promise as a path to optimize outcomes. This proposed presentation will provide a description of ways to adjust MI techniques to improve outcomes when working with adolescents or young adults who present with a gambling problem. Presentation topics will include screening tools, use of key MI techniques (e.g., decisional balance, triggers, and cravings), and dealing with client pushback. The presentation will be interactive. The speaker will engage attendees with targeted questions and issues for group discussion.

- **How Preventing and Treating Problem Gambling Gets Under the Skin**

Ken C. Winters, Ph.D., Senior Scientist, Oregon Research Institute (MN location), Falcon Heights, MN

Epigenetics is a science that helps explain how environmental factors work "under the skin" by directly modifying gene expression without altering the underlying genetic code or structure itself. There is growing recognition that epigenetics is a contributing factor to addictive behaviors. It is intriguing to consider that prevention and treatment efforts to address problem gambling are influential via epigenetic processes. This presentation will explore the emerging science of epigenetics and its role in understanding the development, prevention and treatment of problem gambling. A basic, user-friendly overview of epigenetics will be provided, followed by how effective prevention and treatment makes its impact on many levels, with one such level being epigenetic influences.

- **Silent Desperation: The Link Between Gambling, Financial Crisis, and Suicide Risk**

Andrew J. Schreier, ICS, CSAC, LPC, BACC, ICGC-II, Community Medical Services & New Life Resources, Inc., Menomonee Falls, WI

Gambling addiction is often called "hidden in plain sight" because it's devastating consequences (financial ruin, emotional distress, and increased suicide risk) frequently go unnoticed until a crisis occurs, even as access to gambling continues to expand. This session will explore the intersection of gambling-related harms, financial crises, and suicide risk as well as provide insights into how gambling can escalate into severe mental health crises and the impact on family members and loved ones. Attendees will learn about key warning signs, intervention strategies, and resources to better support individuals facing gambling-related distress.

- Senior Gambling and Self-Determination Theory

Linda Graves, PsyD, California Council on Problem Gambling, Wheatland, CA

This workshop will look at senior gambling through the lens of self-determination theory. The presenter will use case studies throughout the presentation to illustrate the concepts presented. The workshop will consider the elements of self-determination, which are autonomy, competence, and relatedness, in relation to the aging process. Do older adults gamble because of or in reaction to the losses experienced through diminished self-determination? The facilitator will discuss motivations to gamble, including intrinsic and extrinsic motivations, as well as loneliness and loss. The presenter will discuss the health benefits as well as the health risks associated with gambling. Gambling disorders may accompany other addictive disorders or mental health disorders, so some data on co-occurrence will be presented. How do these factors affect a person's autonomy, competence, and relatedness, the aspects of one's self-determination?

- Adolescent Sports Gambling: Who is Doing it and How is it Being Done

Jerry Bauerkemper, BS, CDGC, Problem Gambling Services Consultant - Iowa Problem Gambling - Iowa Problem Gambling Services, Galveston Island, TX

Participants will begin to understand the similarities and differences between adult sports gamblers and adolescent/young adult sports gamblers. The workshop will look at the percentage of young adults sports gambling and the prevalence of disordered gambling among youth. The workshop will also look at possible treatment options and ramifications.

- Helping to Promote Change for People With Gambling Disorders

Michael Goldman, MA, LPC, CRADC, PCGC, CEAP, SAP, Glenview, IL

The purpose of this training is to help the participant understand the types of change for people with gambling disorders and to better cope with them. It will examine resistance and acceptance to change. The Stages of Change and Intentional Change Theories will be described. There will also be discussion on how to improve one's capacity to deal with change.

- Jammed Triggers: Changing the Trajectory Linda Graves, PsyD, California Council on Problem Gambling, Wheatland, CA

This workshop teaches cognitive behavioral tools to assist clients in being able to have an urge or trigger for gambling without having that progress lead to a slip, a lapse or a full-blown relapse. The works of Drs. Marlatt, Larimer, Ciarrocchi and Bandura will be used to model techniques of "putting a fence around a trigger" and relapse prevention, including functional analysis, ego depletion, and cognitive restructuring. A discussion of how mindfulness interplays with these CBT tools illustrates how these modalities can be used together in treatment. The workshop concludes with a discussion of people's beliefs about their capabilities or self-efficacy.

- How to Identify and Deal with the Financial Problems that May be Related to Problem Gambling

James Harrison, MS, CSAC, LPC, ICGC-II, BACC, Evidence Based Counseling Services, New Berlin, WI

This workshop is designed to discuss and share the problems and consequences that may be a result of problem gambling and how to deal with these issues. Topics to be discussed are: identifying the consequences, money management, reducing access to cash, protecting assets, debt repayment, bankruptcy, and where to get professional help and support.
